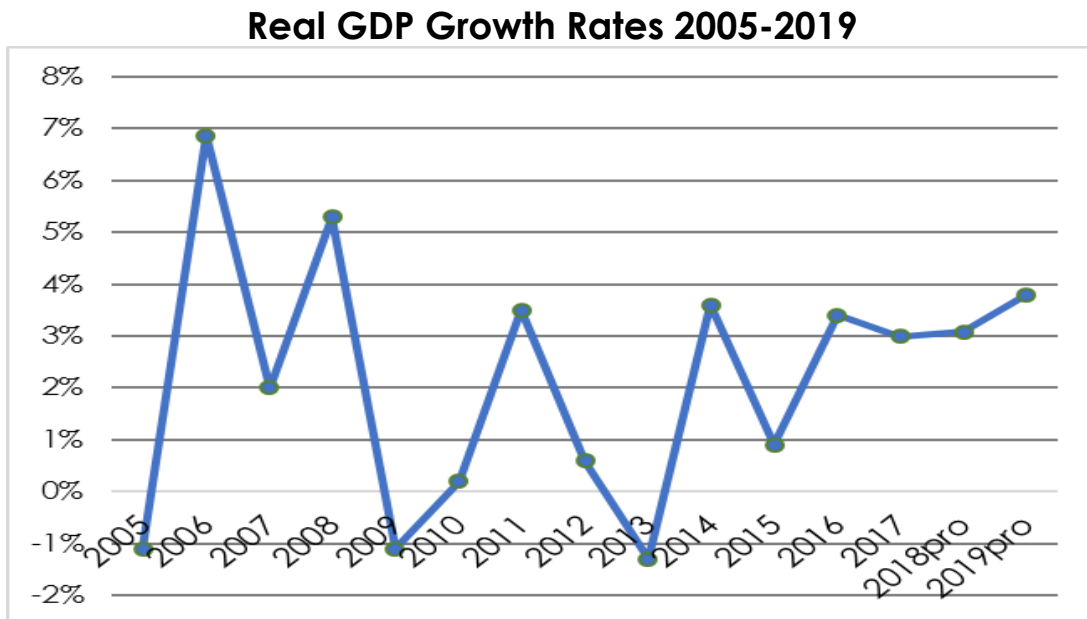

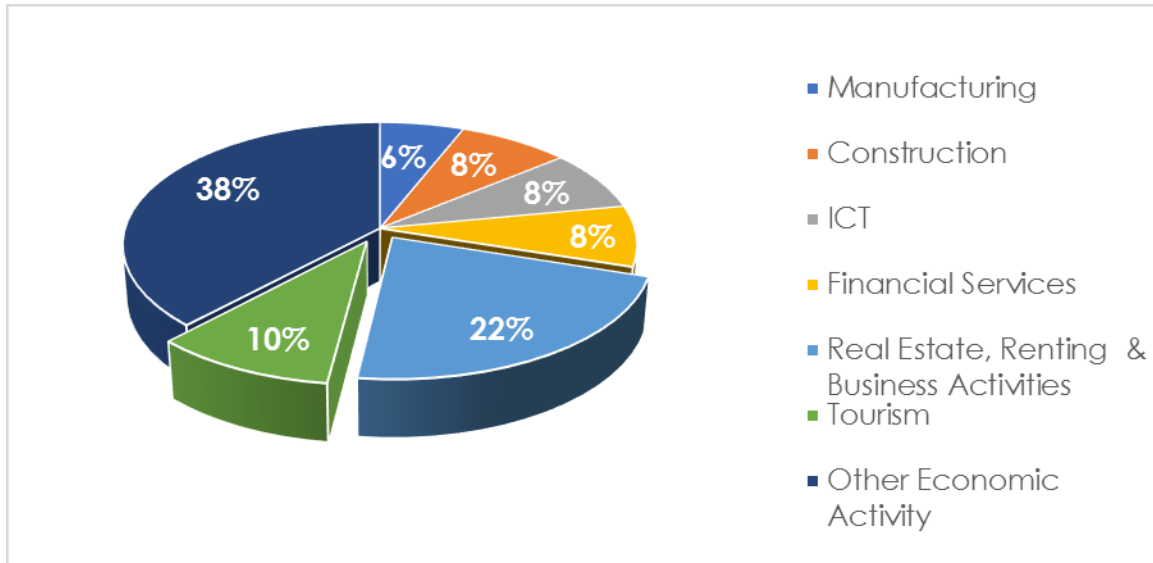

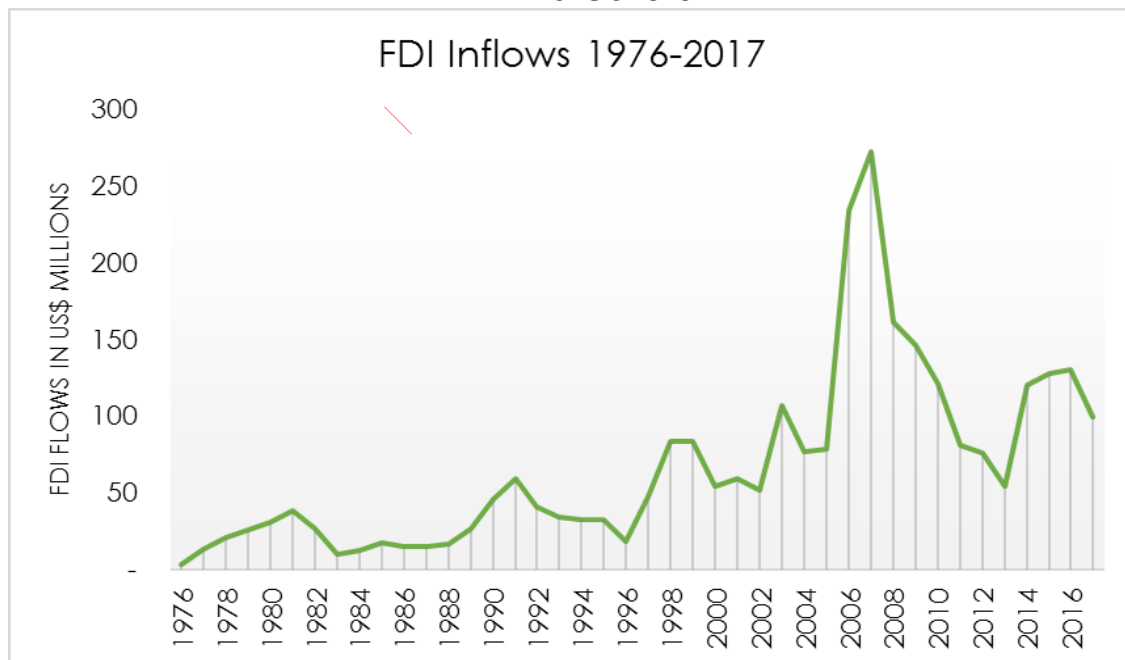

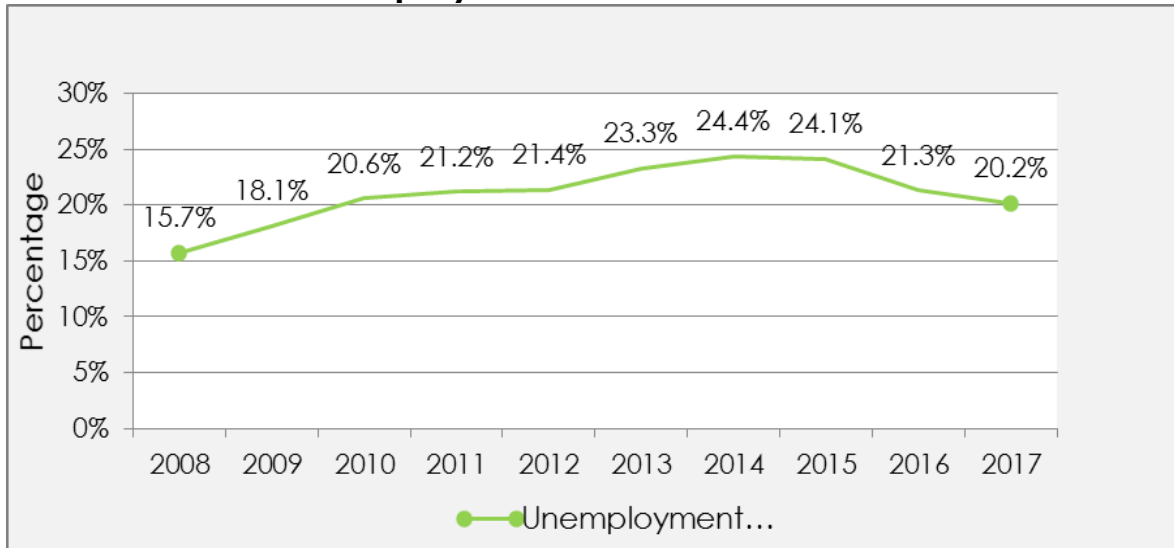

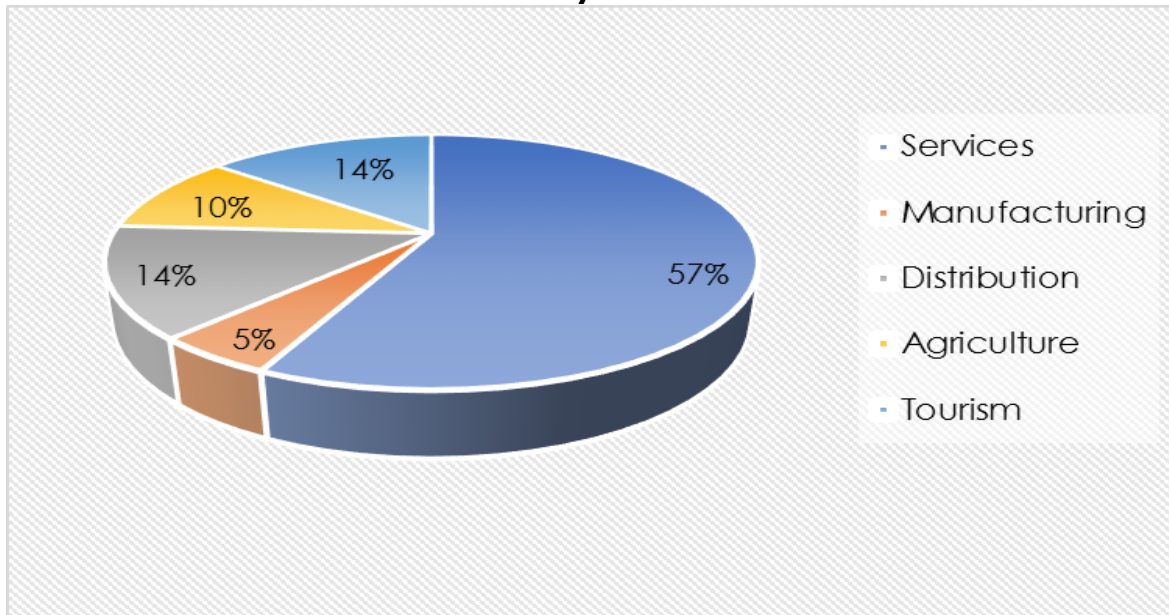

Unemployment Rate 2006 – 2017



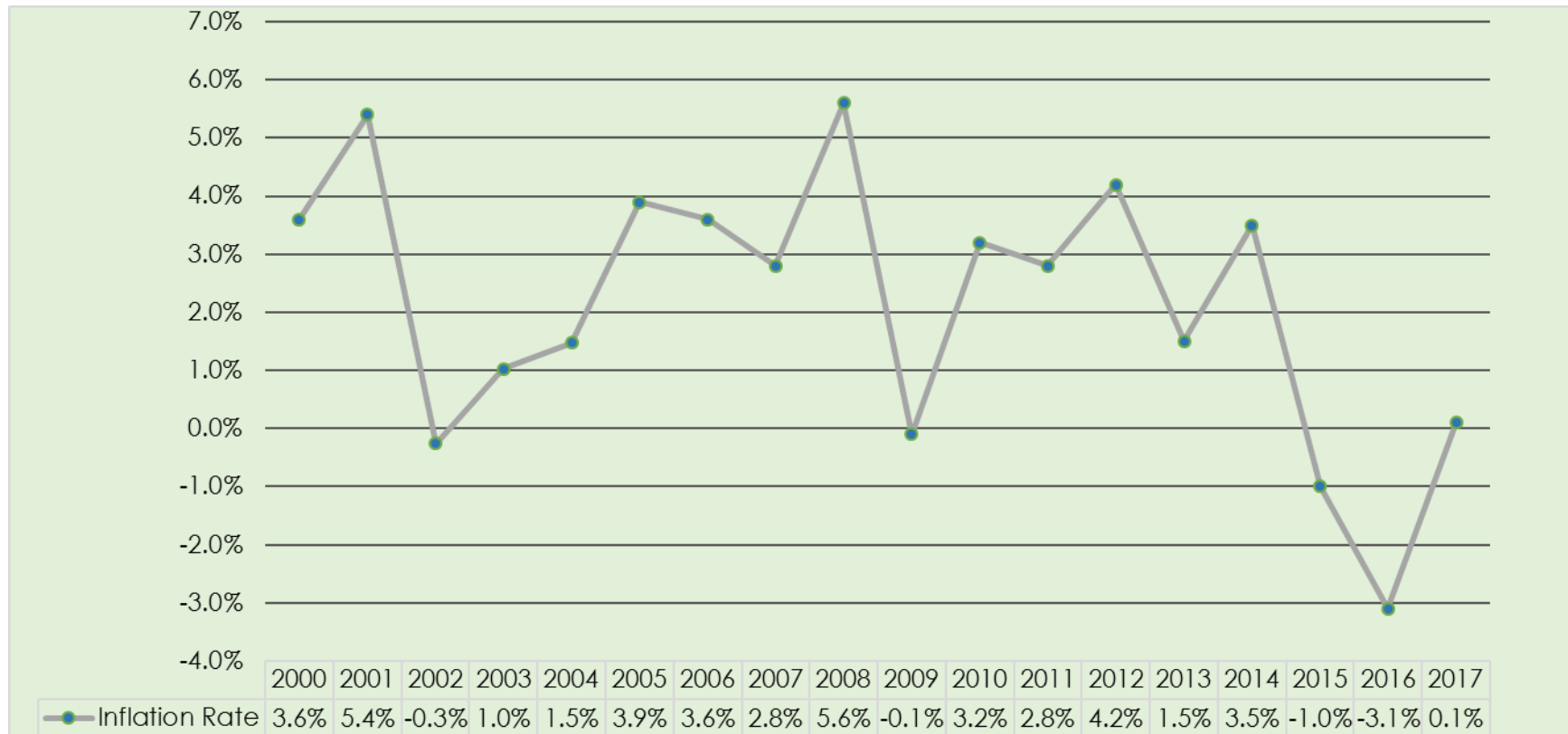

Labor Force Structure by Economic Sector 2017



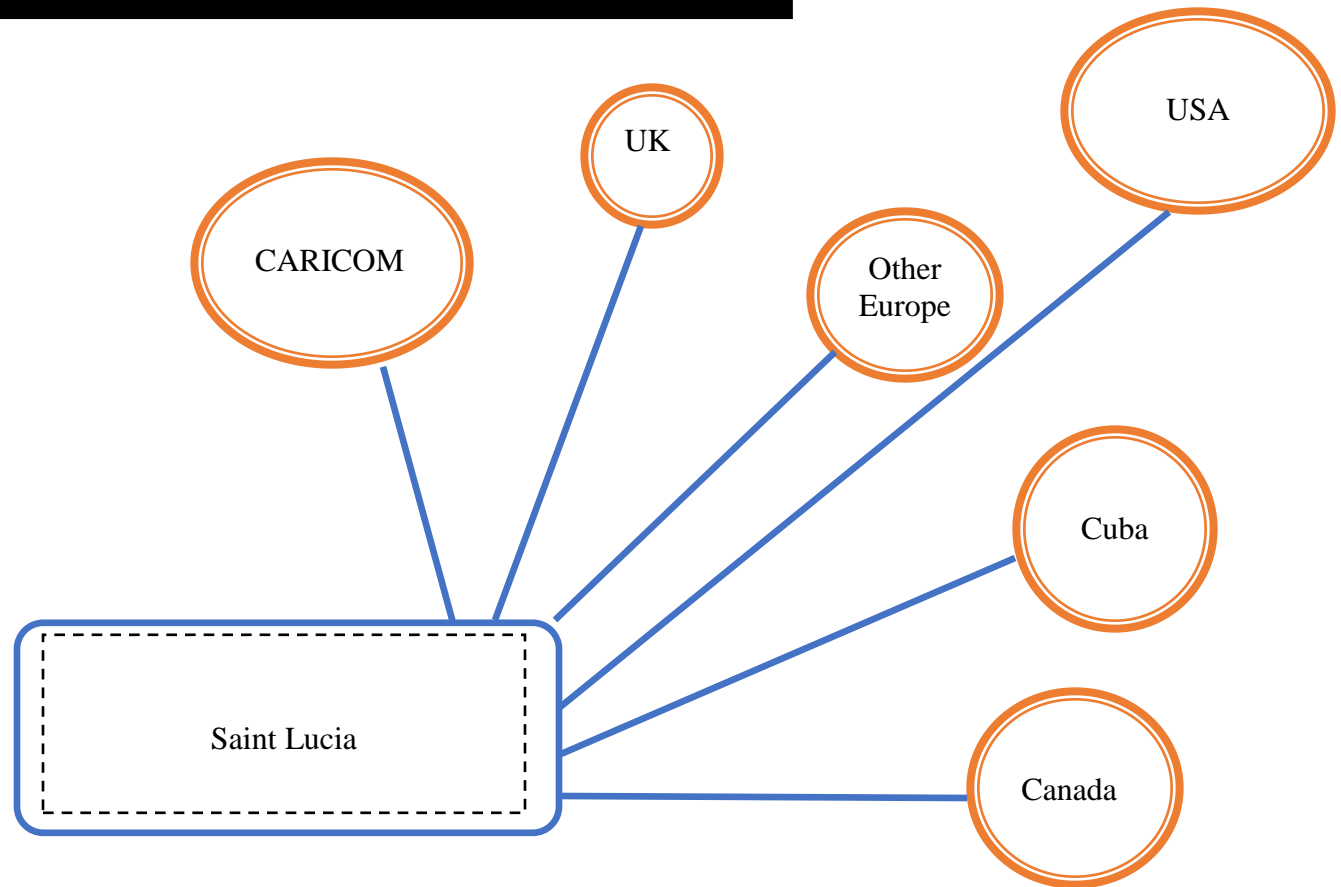

Inflation Rate

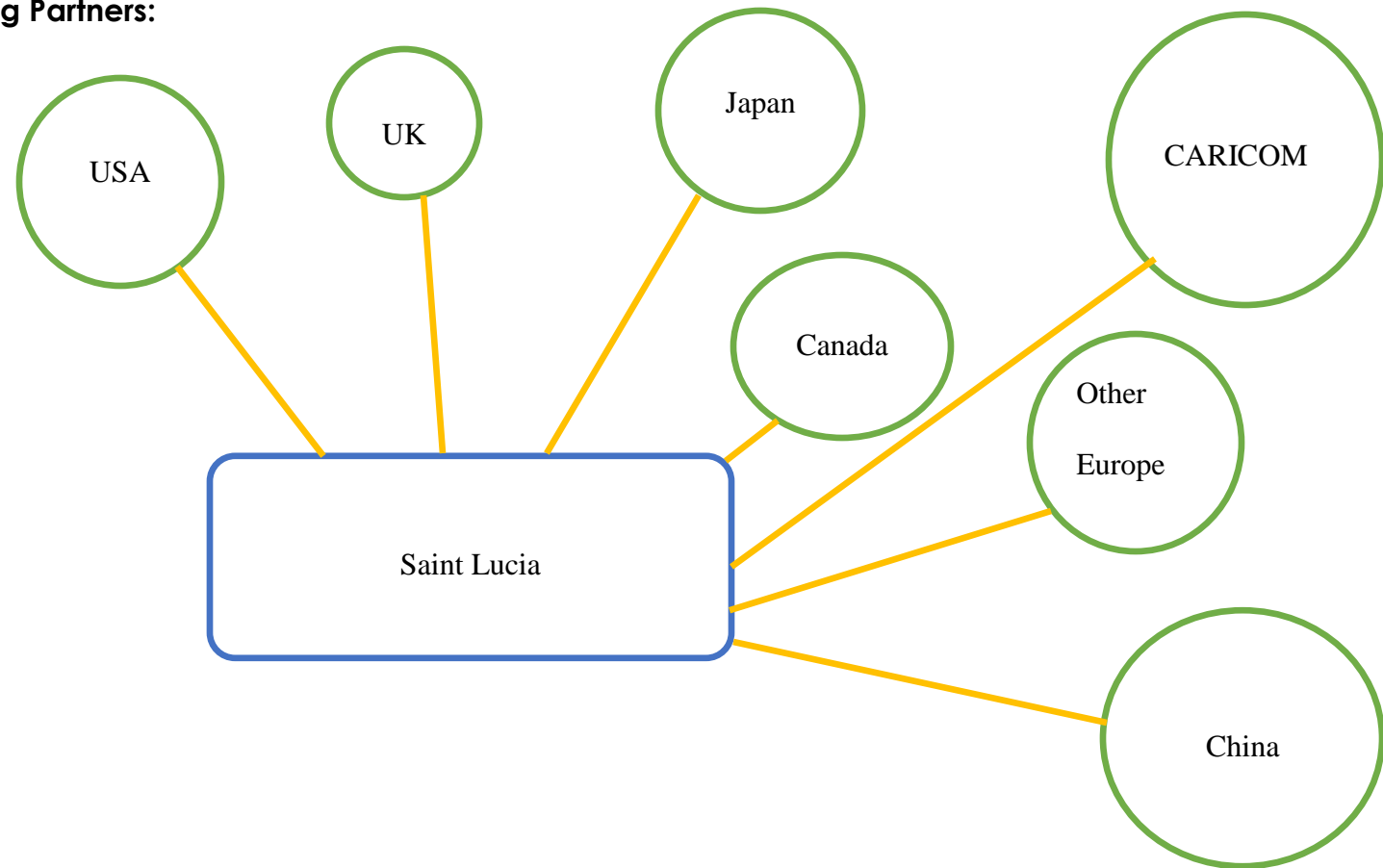

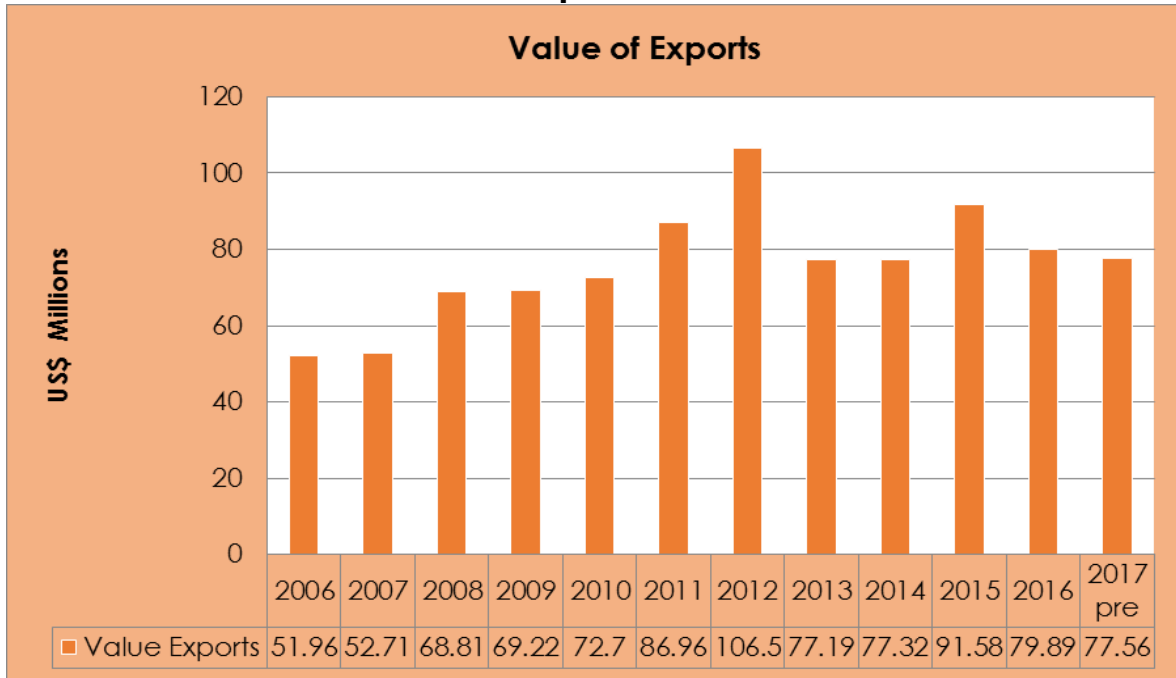

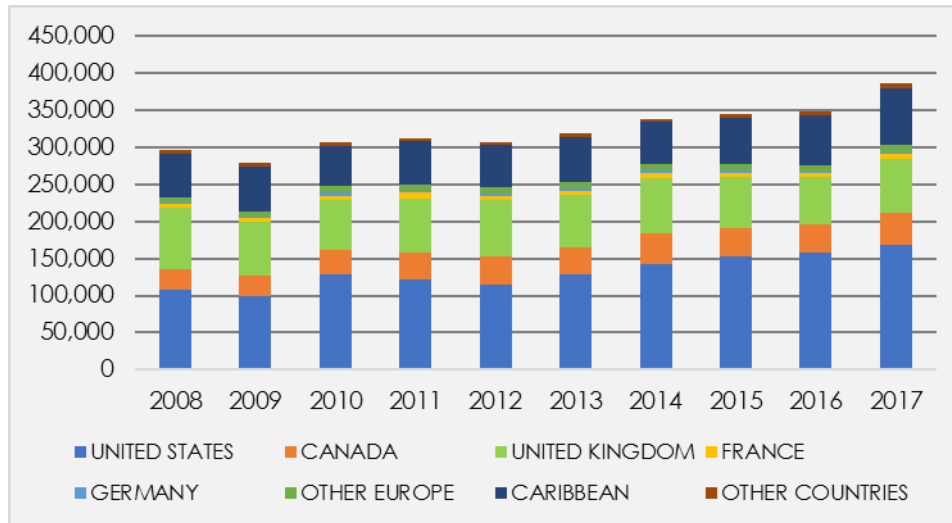

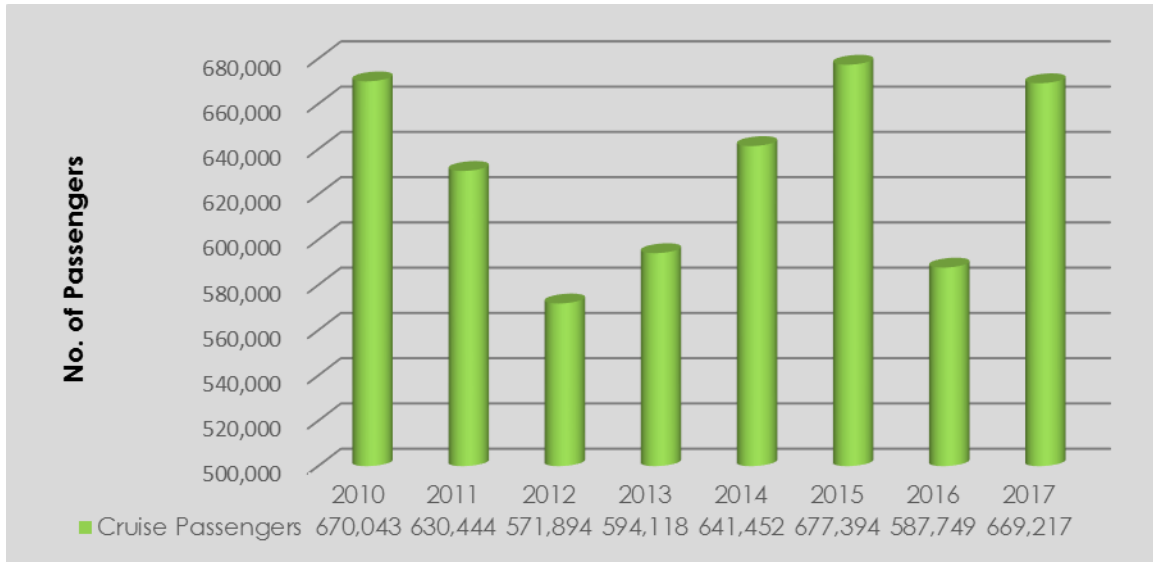

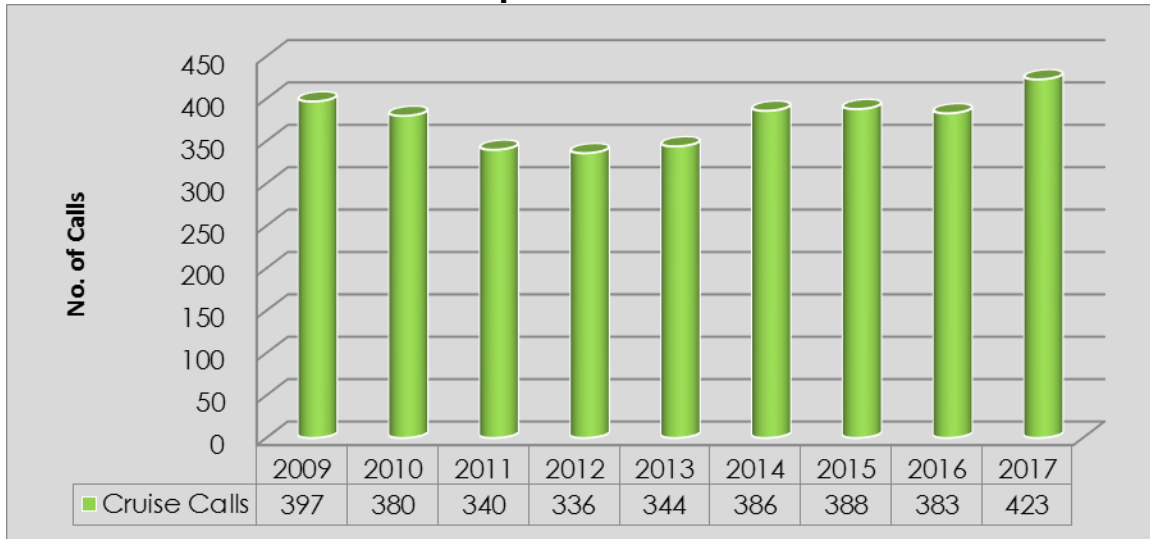

Cruise Travel 2010 – 2017



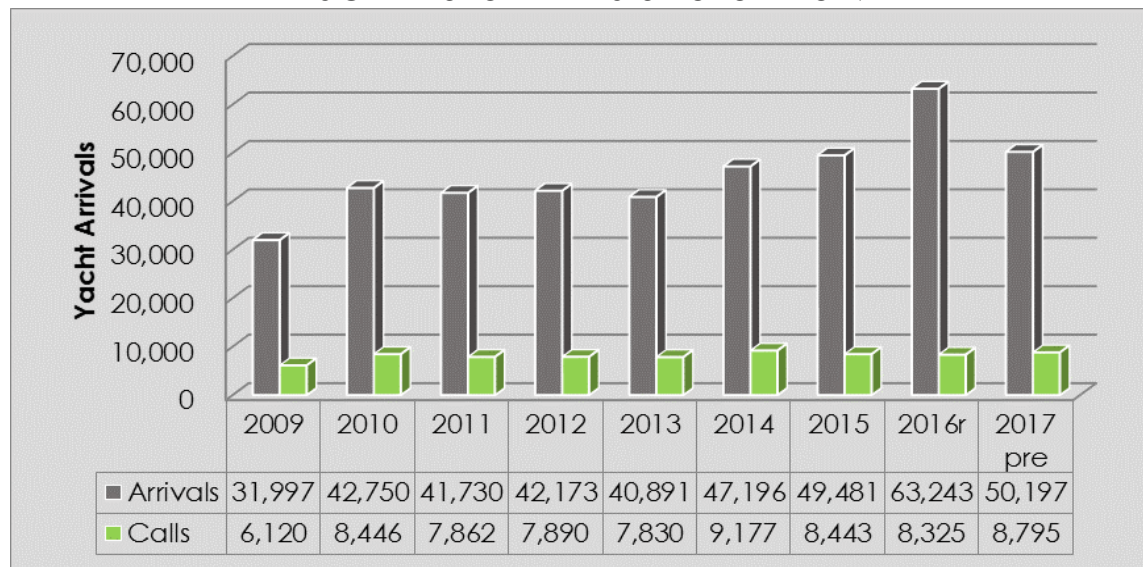

Cruise Ship Calls 2010 – 2017



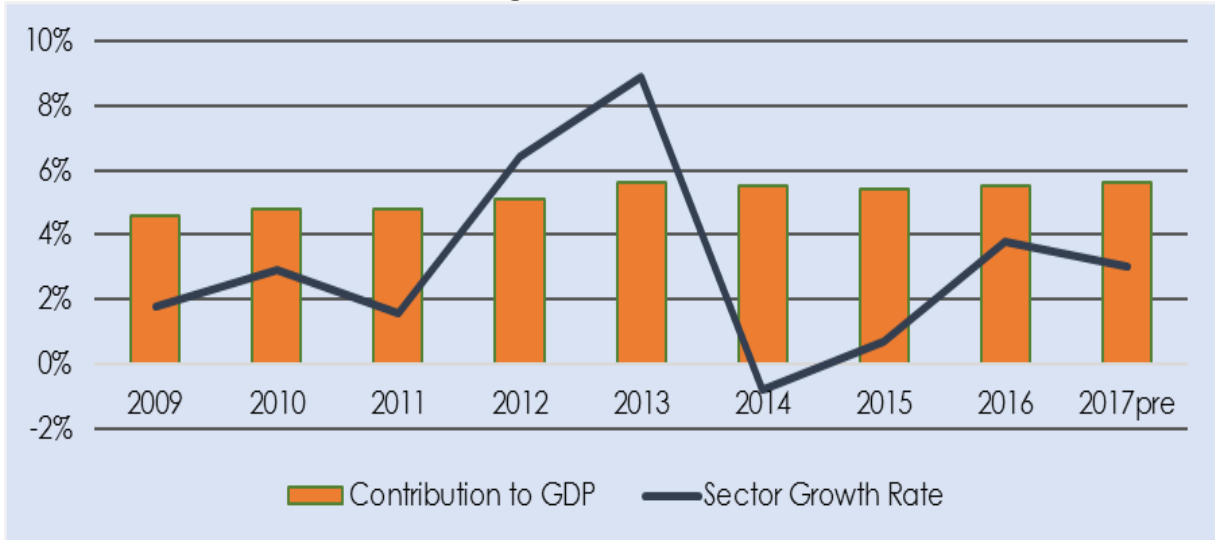

Yacht Visitor Arrivals 2010 – 2017



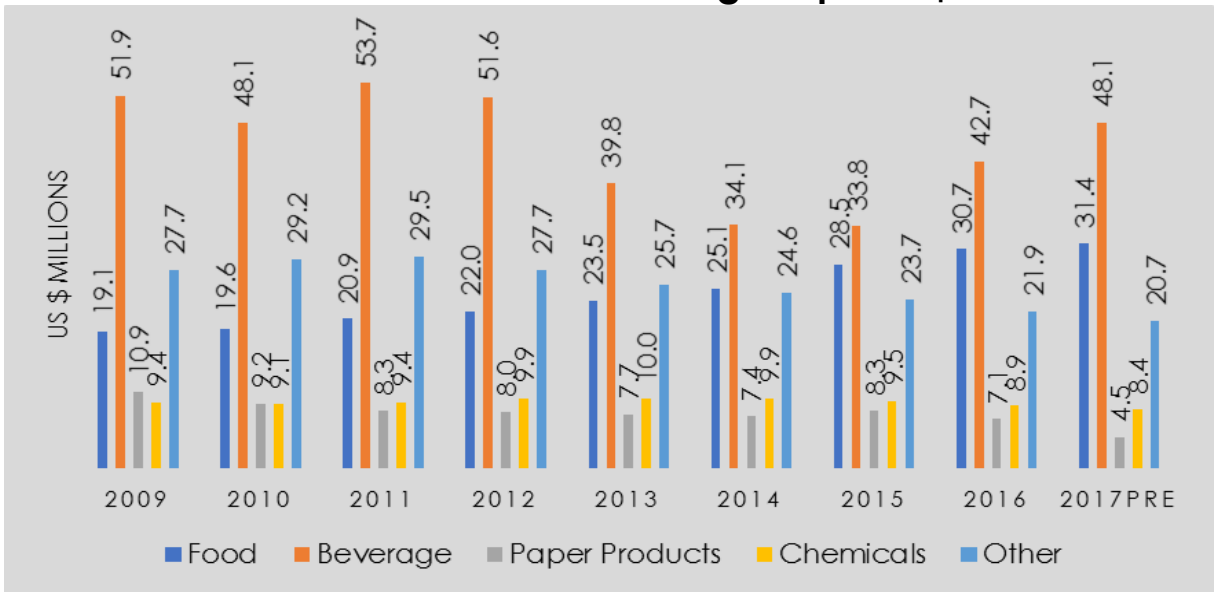

Manufacturing Sector Performance



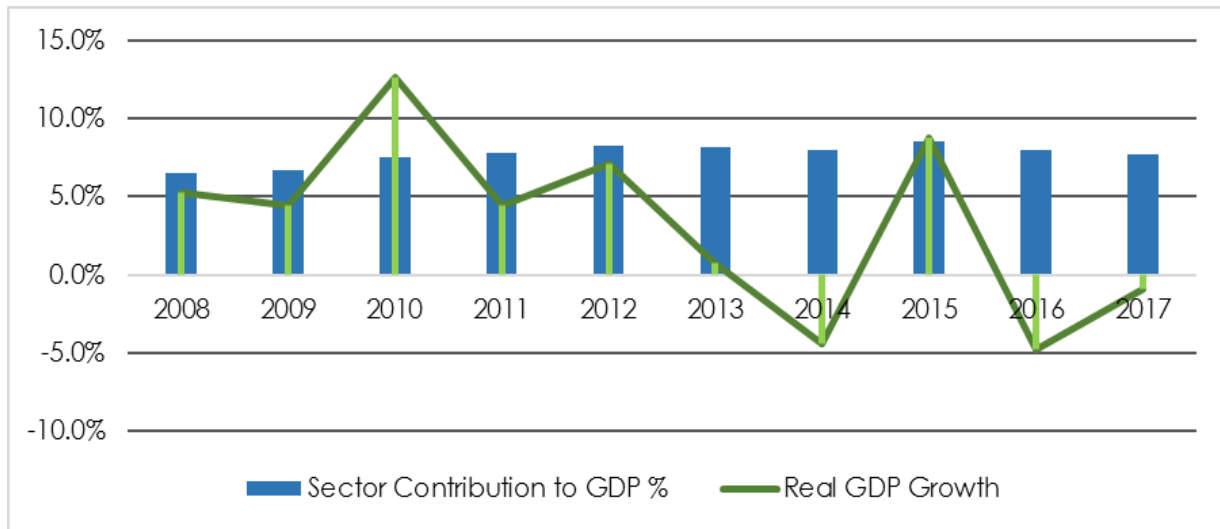
