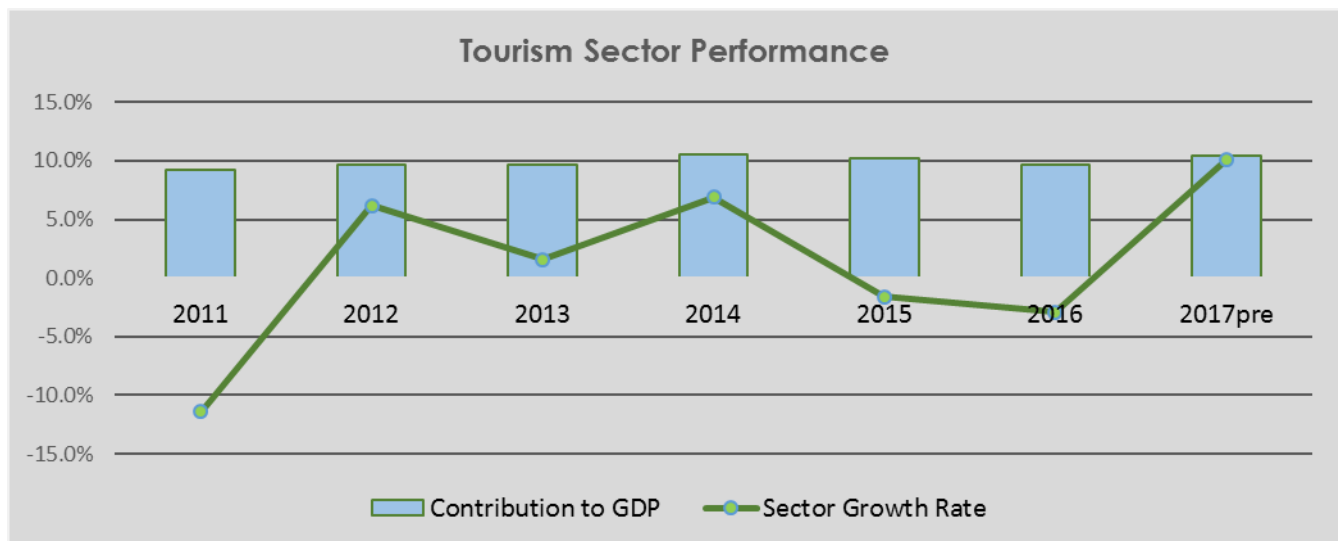

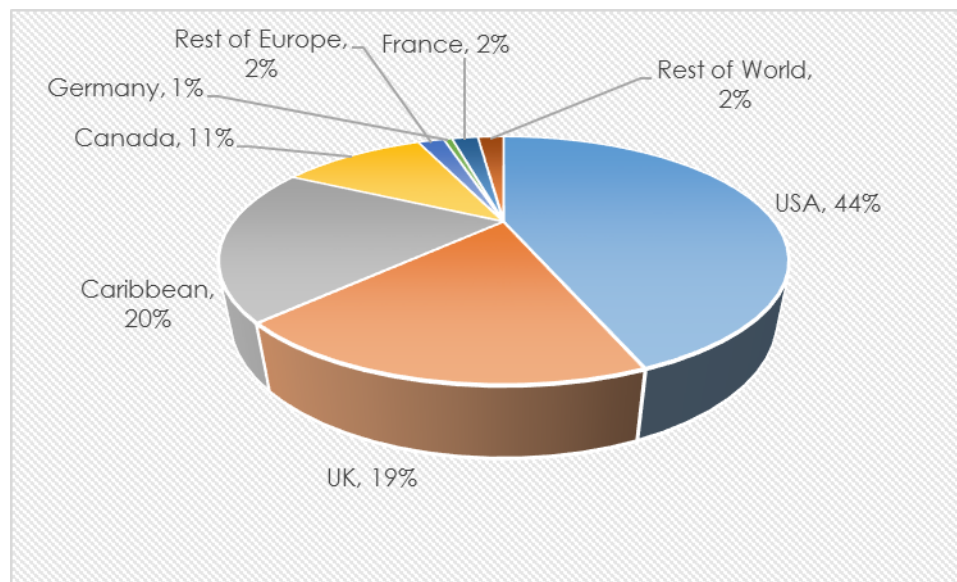

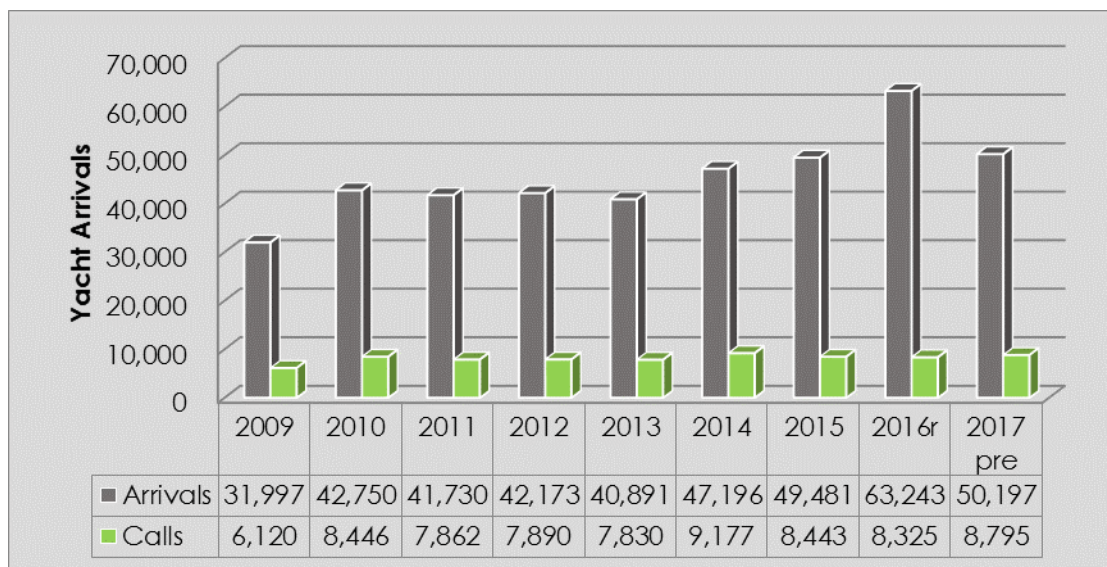

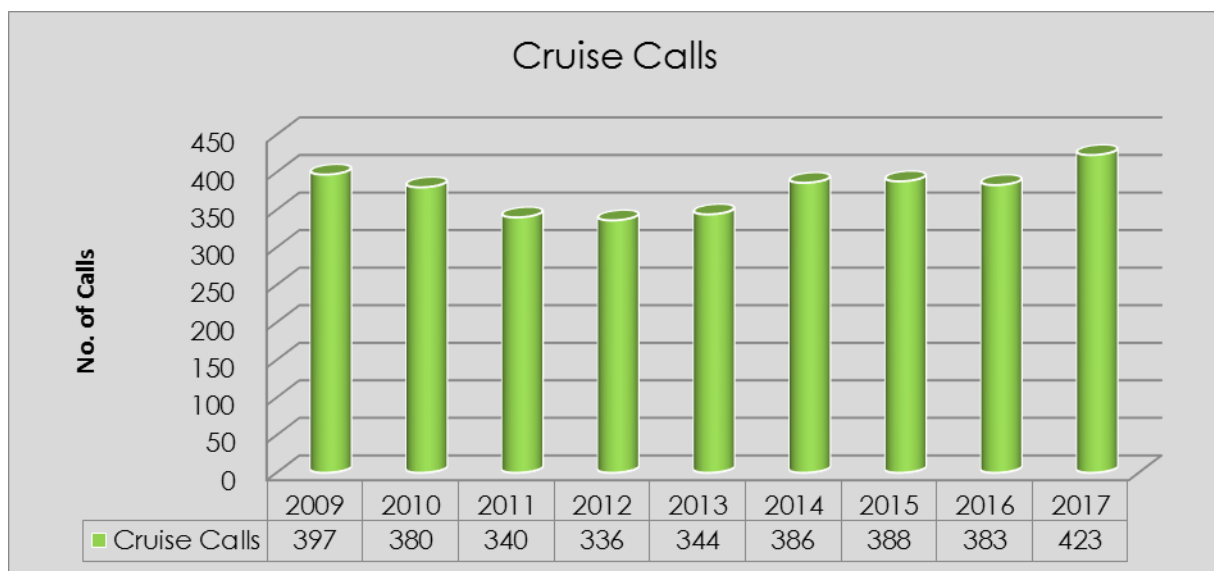

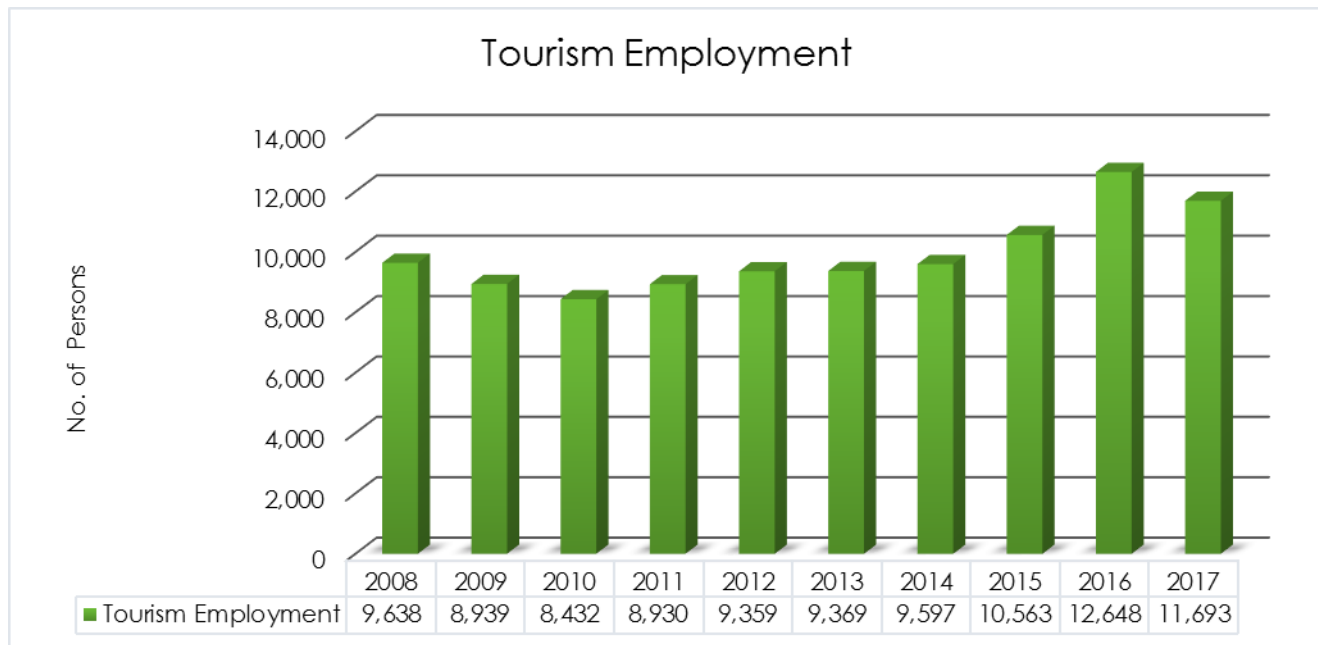

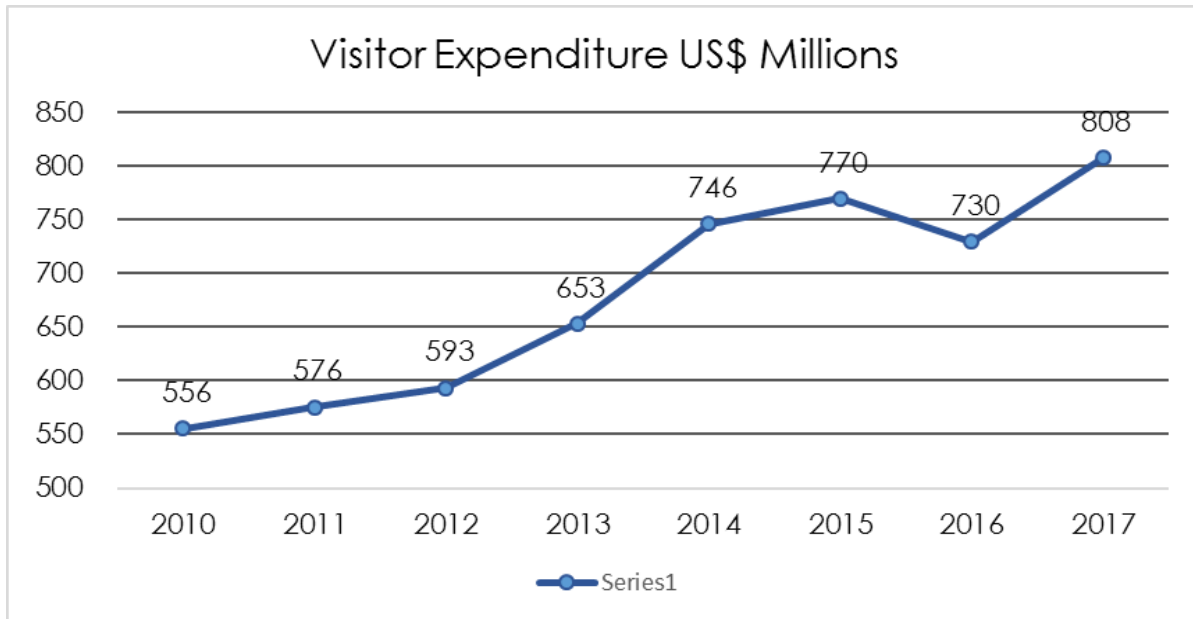

**Saint Lucia Visitor Expenditure Trend**



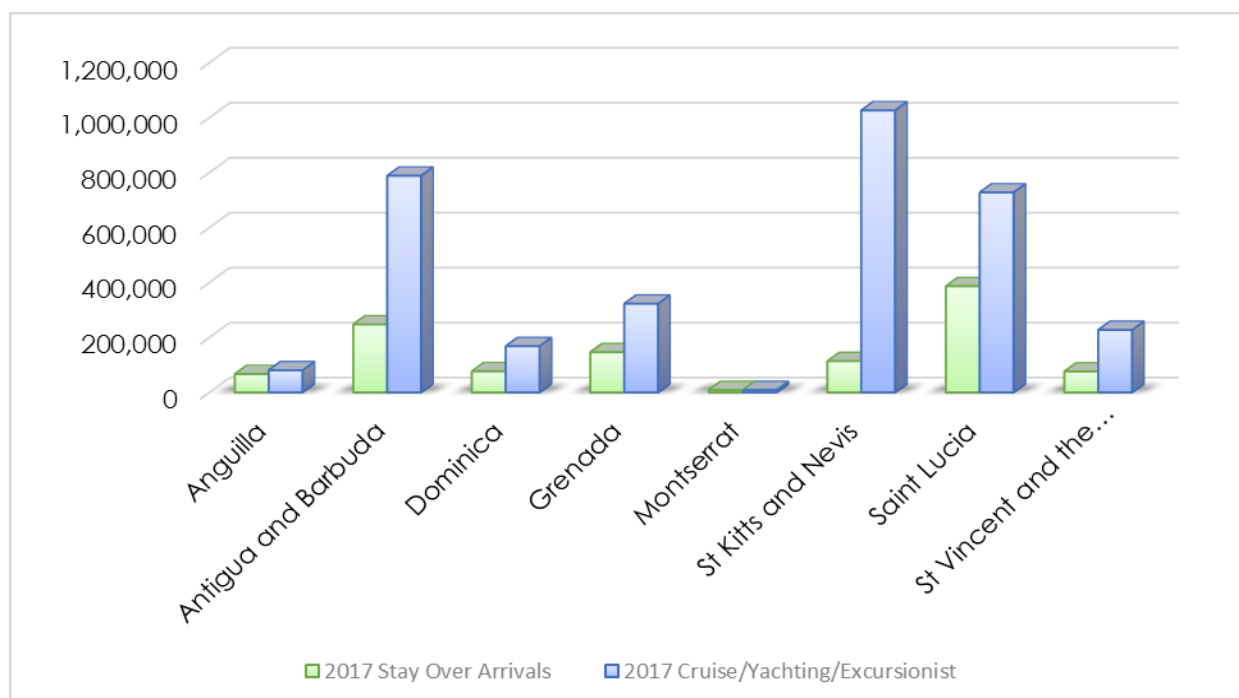

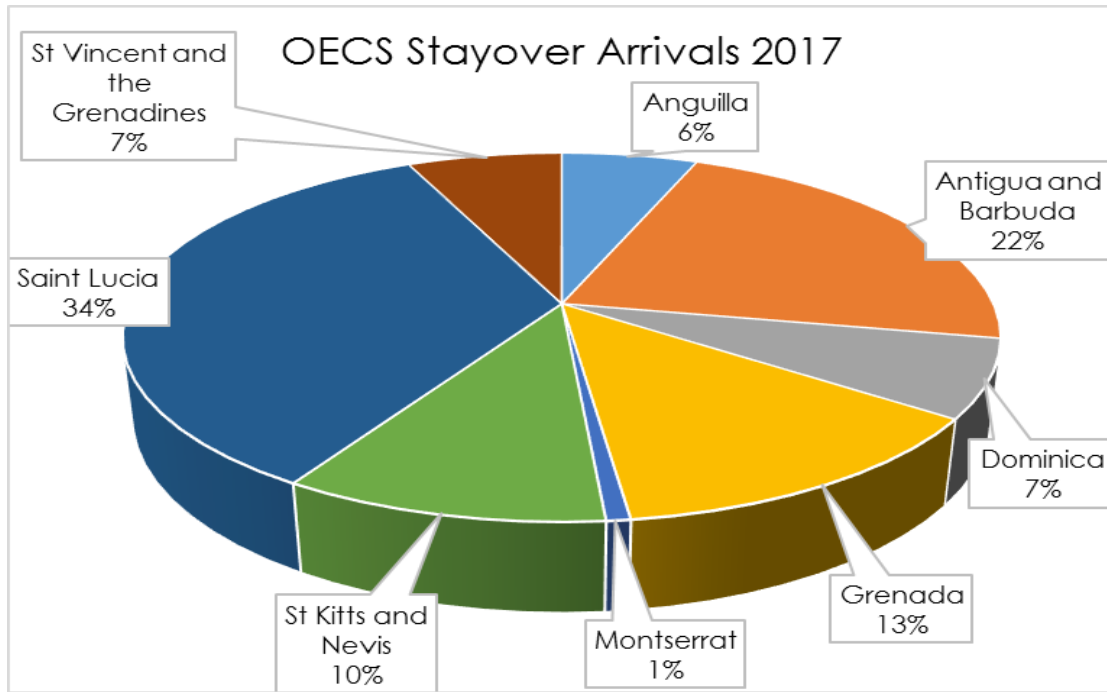

## OECS Visitor Arrivals

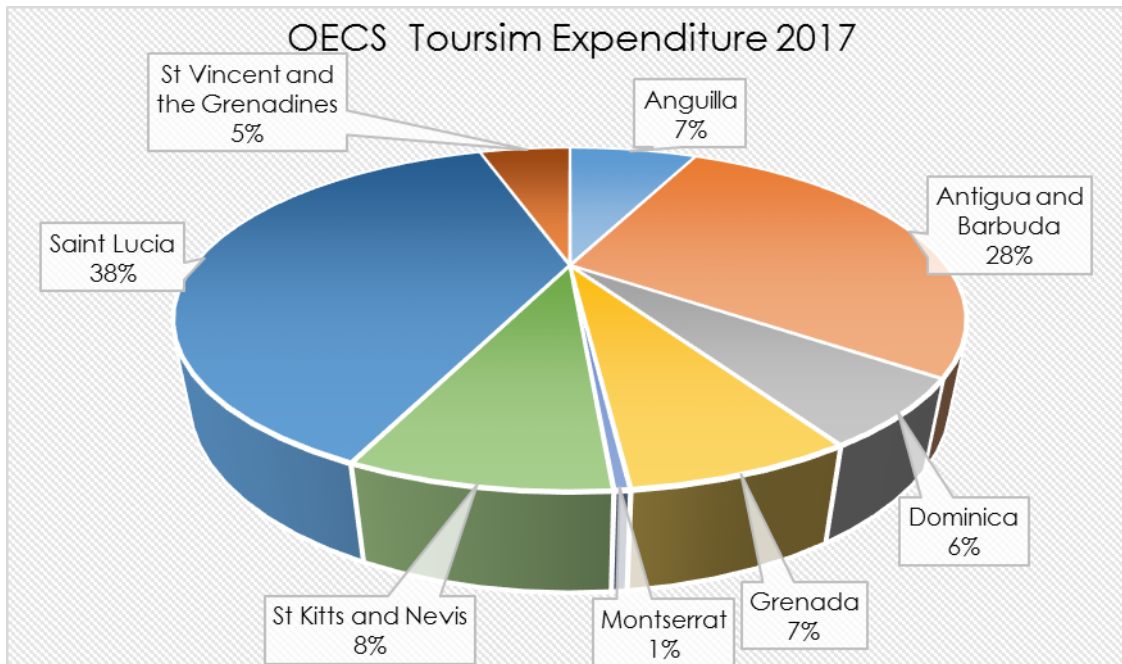
